Note :- (6) SC/ST candidates included in the Short List are required to produce Community Certificate (in Form III/Digitally Signed) issued by the competent Revenue Authority, candidates belonging to Other Reservation Groups are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O(P) No 81/2009/SCSTDD dated 26.09.2009 and those belonging to Economically Weaker Section Category are required to produce EWS certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevant documents at the time of OTR Verification of original documents.
