The marks secured by the last candidate in the Main List is **41.33** (Forty One(point)three three). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Economically Weaker Section, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including available/sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present in person and produce the original documents for **One Time Verification** and interview. **Date, time and Venue of OTR Verification** and interview will be intimated through SMS & profile message.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated:26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate vide GO(Ms) No. 02/2020/P&ARD Dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 11.7.2025 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : .ER16-3/1/2026-KPSC Dated:19.1.2026
