

Note :- (6) Candidates belonging to the Other Backward Classes included in the Probability List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated:26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahasildar along with other documents at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **20-09-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
