Note 2. **25 (Twenty Five )** candidates who have been found provisionally eligible, secured top marks in the OMR Examination are included in the Main List of this Short List. The Marks secured by the last candidate in the Main List is **35.67 ( thirty five (point) six seven )**. For the purpose of satisfying the rules of reservation of appointment to Scheduled castes, Scheduled Tribes, Other Backward Classes, Economically Weaker Sections and Differently abled necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of Merit of the candidates belonging to such classes.

Note 3. The Short List has been prepared based on the details furnished by the candidates in the application and subsequent claim if any made will not be entertained at any stage of the selection.

Note 4. The candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date, Time & Venue of OTR Verification and Interview will be intimated through SMS and Profile Message in due course.

Note 5. According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note 6. Candidates included in the Short List who are eligible for Reservation for Other Backward Classes are required to produce Non -Creamy Layer Certificate ( For State Employment Purpose) obtained from Village Officer and SC/ST Candidates are required to produce Community Certificate (Form III /digitally signed) issued by the Revenue authority (not below the Rank of Tahsildar) and candidates who claimed EWS Reservation are required to produce EWS Certificate issued by the Revenue Authority along with other documents at the time of OTR Verification of original documents

Note 7. Copy of answer scripts of the OMR Test held on 04-11-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note 8. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER2-1/1/2026-KPSC DATED:20.01.2026.
