NOTIFICATION

It is hereby notified that no eligible and qualified candidates are available to be included in the Ranked List for selection to the post of **MIXINGYARD SUPERVISOR (PART I) (GENERAL CATEGORY) in KERALA STATE CO- OPERATIVE RUBBER MARKETING FEDERATION LTD. (Cat. No. 040/2024)** on the basis of OMR Examination held on 15.10.2025 in response to the notification published in the Gazette dated 01.04.2024. Hence further selection procedures relating to the above post stands cancelled.

NOTE (1) :-According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for rechecking through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. **85** (Rupees **Eighty Five** only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner (ie via email/Tappal/Direct) will not be considered. A period of 15 (Fifteen) days time, to apply for rechecking of Answer Scripts, will be allowed to the candidates with effect from the date on which this Nil Notification is uploaded in the website of the Commission (i.e on or before 10.04.2026).

NOTE (2) :-Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. **335** (Rupees **three hundred and thirty five** only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time, to apply for photocopy of OMR sheets, will be allowed to candidates with effect from the date on which this Nil Notification is uploaded in the website of the Commission. (i.e on or before 10.04.2026). Applications submitted in any other manner (i.e via email/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Please note that in the case of Ranked Lists of those posts for which common examinations were conducted, the copy of OMR Answer sheets will be provided only after the publication of all the Ranked Lists of those posts for which the candidate has participated. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be

initiated against those who do so. Applications received after the prescribed date will not be entertained. Applications submitted through email/by post/in person will not be considered
