

Note :- (2) The list has been prepared by including the eligible and qualified candidates who have secured top marks in the OMR Test, based on the details furnished by the candidate in the application for the post. Subsequent claims made will not be entertained at any stage.

Note :- (3) **15(Fifteen)** candidates who have secured top most marks in the OMR examination are included in the Main List of this Short List. Marks secured by the last candidate of the Main List is **66.00 (Sixty Six (point) Zero Zero)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribe, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification and interview will be intimated to candidates through Profile message and SMS in due course**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who belongs to Other Backward Classes are required to produce **Non Creamy Layer Certificate** (State Employment Purpose) issued by Village Officer , SC/ST Candidates are required to produce **Community Certificate** issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce **EWS Certificate** issued by Village Officer as per GO(MS) No. 2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification. Candidates are required to produce a **Medical Certificate** in the prescribed form as per the Gazette notification, certifying the requisite visual standards, issued by a Medical Officer not below the rank of Assistant Surgeon at the time of verification.

Note :- (7) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short list without further notice

Note :- (8) Copy of answer scripts of the OMR Test held on **18-12-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after publication of Ranked List. Detailed instructions will be published in the Ranked List notification to be published for the post.

Note :- (9) No answer scripts are invalidated for this post vide Invalidation Notification No: ER14-2/1/2026-KPSC dated 24/03/2026
