The marks secured by the last candidate in the Main List is **37.67 (thirty seven (point) six seven)**. For the purpose of satisfying rules of reservation of appointment to Scheduled Castes, Scheduled tribes, Other Backward Classes and Economically Weaker Section category, necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:-(4) Candidates included in the Short List should be present in person and produce the original documents for One Time Registration Verification and Interview. **Date,time and Venue of OTR Verification and Interview will be intimated in due course through SMS/Profile Message.**

Note:-(5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note:-(6) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, candidates belonging to SC/ST candidates are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahasildar and candidates belonging to Economically Weaker Sections are required to produce EWS Certificate in the format prescribed vide G.O(Ms) No.2/2020 P&ARD dated 12.02.2020 issued by the Village Officer as proof of their claim, along with other relevant documents at the time of OTR Verification.

Note:-(7) Copy of answer scripts of the OMR Test held on 04.11.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note:-(8) Candidates whose Register Numbers are invalidated are advised to refer to Notification No.ER2-1/1/2026-KPSC Dated 20.01.2026.
