Marks secured by the last candidate of the Main List is **72 (Seventy two)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribe and Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

**Note :- (4)** Candidate included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date, Time and Venue of OTR Verification and Interview will be intimated through Profile message and SMS** in due course. The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

**Note :- (5)** According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

**Note :- (6)** Candidates belonging to Other Backward Classes included in this Short list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Thahilsdar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the concerned authority.
