Note:- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Probability List does not confer any right on the candidate for inclusion in the Ranked List.

Note:- (2) The Probability List has been prepared based on the details furnished by the candidates in the application and subsequent claims if any, made will not be entertained at any stage.

Note :- (3) The Main List of List I comprises 10 (Ten) eligible and qualified candidates who possess both the prescribed educational qualifications and required experience. Those Candidates secured the highest marks in the OMR Test, with the last candidate in the list scoring 12.33 marks. To satisfy the rules of reservation for the SC, ST, Muslim and Viswakarma Categories, supplementary lists have been prepared by including eligible candidates from lower mark ranges in order of merit. No eligible and qualified candidates were available for inclusion in the supplementary lists for the LC/AI, OBC, SIUC Nadar, SCC, Dheevara, Hindu Nadar and EWS Categories. List II of the Probability List includes candidate who possess the prescribed educational qualification but lack the required experience. This List II Consists of SC Category 3 (Three) candidates; the last candidate secured 81.33 marks and ST Category 4 (Four) candidates; the last candidate secured 45.33 marks.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date, time and Venue of OTR Verification will be intimated through SMS and Profile message.

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to the Other Backward Classes included in the Probability List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated:26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahasildar along with other documents at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 20-09-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER 2-3/2/2026-KPSC dated 28/01/2026.
