Note :- (4) Candidates included in the Short List should be present in person for **Endurance Test with the Original ID proof and admission ticket** issued for the said test. Date, **Time and Venue of Endurance Test will be published in due course.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate(In form III/Digitally signed ) issued by the concerned Revenue authority and Candidates belonging to other reservation group should produce Non Creamy Layer Certificate issued by Village Officer, Candidates who claimed EWS benefit should produce EWS certificate issued by Village Officer at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 20-12-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No: ER16-1/1/2026-KPSC Dated 02-03-2026 of the Secretary, KPSC,Thiruvananthapuram.
