

**Note:- (2)** The Probability List is prepared based on the details furnished by the candidates in their applications and subsequent claims, if any, made will not be entertained at any stage .

**Note :- (3) :- 32 (Thirty Two)** candidates who have secured top most marks in the OMR Examination held on 15.11.2025 are included in the Main List of the Probability List. The marks secured by the last candidate in the Main List is **77 ( seventy seven )** marks . For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any), necessary Supplementary Lists have been prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

**Note:- (4)** Candidates included in the Probability list should present in person and produce the original documents for **One Time Verification. Date,time and Venue of OTR Verification will be intimated through profile message & SMS.**

**Note:- (5)** Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahildar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate in the format prescribed vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the Village Officer as proof of their claim, along with other relevant documents at the time of OTR verification.

**Note :- (6)** According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

**Note :- (7)** Copy of answer scripts of the OMR Test held on 15.11.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidate whose Register Number is invalidated is advised to refer Notification **No: ER 2-3/1/2026-KPSC, Dated: 28.01.2026.**
