Note :- (5) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Short List are required to produce Community Certificate (Form III or Digitally Signed) issued by the Revenue authority not below the rank of Tahsildar in proof of their claim along with other relevant documents at the time of OTR Verification of original documents.

Note :- (8) Copy of answer scripts of the OMR Test held on **02-12-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts of candidates are invalidated for this post (Invalidation Notification No : **ER 3-2/1/2026-KPSC dated 17-03-2026**).
