Note :- (3) The Probability List is Prepared based on the details furnished by the candidates in the application and subsequent claims will not be entertained at any stage.

Note:- (4) Candidates included in the Probability List should present and produce in person with the original documents for One Time Verification. Date,time and Venue of One Time Verification will be intimated through profile message and SMS in due course.

Note :- (5) Candidates included in the Probability List who belong to Other Backward Classes are required to produce Non Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/09/SCSTDD dated. 26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Thasildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(Ms) No.2/2020/P&ARD dated 12.02.2020 along with other documents at the time of One Time Verification.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the Common OMR Test held on 27-10-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer Scripts are invalidated as per Notification **No.ER16-2/10/2025-KPSC dated 31.12.2025.**
