Note :- (3) 27 (Twenty Seven) candidates who have secured top most marks in the Common OMR Examination held on **17.11.2025** are included in the Main List of this Short List. The Marks secured by the last candidate in the Main List is **10.33 (ten (point) three three)** marks. For the purpose of satisfying rules of reservation of appointment to Scheduled Castes, Scheduled tribes, Other Backward Classes and Economically Weaker Section category, necessary supplementary lists is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person and produce the original documents for One Time Registration Verification and Interview. **Date, Time and Venue of OTR Verification and Interview will be intimated through profile message and SMS.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate issued by Village Officer as per G.O.(P) NO. 81/2009/SCSTDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III /Digitally signed issued by the Revenue authority not below the rank of Tahsildar and candidates belonging to Economically Weaker Section category are required to produce EWS Certificate vide G.O. (M.S) No. 2/2020/P&ARD dated 12.02.2020 issued by the competent Revenue Authority along with other relevant documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **17.11.2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (8) No Answer scripts are invalidated for this post as per Invalidation Notification No. ER16-3/1/2026-KPSC Dated 19.01.2026.
