

Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The Short List has been prepared by including eligible and qualified candidate who have secured an aggregate minimum of 40% marks for all three Parts and a separate minimum of 9 (nine) marks out of 30 in Part III of Paper I & a minimum of 40% (i.e. 20 marks out of 50) for Paper II in the Descriptive Examination held on 10.11.2025, in the Main List. As per the notification, the minimum pass marks are lowered only for SC/ST candidates.

Note :- (3) **11 (Eleven)** candidates are included in the Short List based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage.

Note :- (4) Candidates included in the Short List should upload in profile and produce in person the original documents for One Time Verification and Interview. **Date, Time and Venue of One Time Verification and Interview** will be published in due course. The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (5) According to the existing procedure, revaluation and rechecking of answer scripts of Descriptive Examination are not allowed. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to SC/ST Communities are required to produce Community Certificate (Form III or Digitally Signed) issued by the Revenue Authority not below the rank of a Tahsildar in proof of their claim along with other relevant documents at the time of One Time Verification of original documents.

Note :- (7) Scanned image and Tabulation sheet of answer scripts of the Descriptive Examination held on 10.11.2025 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts of candidates is invalidated for this post (Refer Notification No. : ER OSM-2/12/2025-KPSC dated 09/03/2026).
