

Note :- (3) 157 (One Hundred and Fifty Seven) candidates who have secured top marks in the OMR Examination are included in the Main List of this Short List. The mark secured by the last candidate in the Main List of this Short List is 59.87 (Fifty Nine (point) Eight Seven). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and other reserved categories if any, necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person for Endurance Test. The candidates should download their Admission Tickets for the Test from the Official Website www.keralapsc.gov.in of KPSC and appear in person with their original ID Proof. Date, time and venue of Endurance Test will be intimated through SMS and Profile Message in due course.

Note :- (5) Candidates included in the Short List belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dtd.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset Certificate issued by Village Officer as per GO (Ms) No. 3/2024/P&ARD Dtd. 25.04.2024 as proof of their claim, along with other relevant documents at the time of OTR Verification.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on 20-12-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (8) No Answer Scripts of Candidates are invalidated as per Notification No : ER16-1/1/2026-KPSC dated 02-03-2026 of the Secretary Kerala Public Service Commission, Thiruvananthapuram.
