

The marks secured by the last candidate in the Main List is **64 (Sixty Four)**. For the purpose of satisfying rules of reservation of appointments to Scheduled Castes, Scheduled tribes, Other BackwardClasses (and other reserved categories if any) necessary supplementary lists is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person for Physical Measurement and Physical Efficiency Test with the original ID proof and admission ticket issued for the said test. Date, Time and Venue of Physical Measurement and Physical Efficiency Test will be intimated through Profile Message and SMS in due course.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate(In form III/Digitally signed) issued by the concerned Revenue authority and Candidates belonging to other reservation group should produce Non Creamy Layer Certificate issued by Village Officer, Candidates who claimed EWS benefit should produce EWS certificate issued by Village Officer at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 06.12.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No candidates are invalidated for this post as per Invalidation Notification No : ER16-2/2/2026-KPSC dated 12.02.2026.
