Note:- (3) The Main list of **List - I** has been prepared by including **10 (Ten)** eligible & qualified candidates with Experience qualification who have secured top marks in the OMR Test. The marks secured by the last candidate in the main list is **11.67 (Eleven(point)six seven)**. For the purpose of satisfying the rules of reservation of appointment to SC, ST, OBC, and EWS, if any, necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes. **List - II** includes **04 (Four)** lesser qualified SC and ST Candidates each with the prescribed educational qualification but no experience, who have secured top most marks among SC & ST candidates in the OMR Test. The Marks secured by the last SC candidate in the List-II is **70 (Seventy)** marks & the Marks secured by the last ST candidate in the List-II is **62.33 (Sixty Two(Point)Three Three)**.

Note :- (4) Candidates included in the Probability List should present in person and produce the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be ntimated through profile message and SMS in due course.**

Note:- (5) The Register Number of those candidates who do not produce the required documents with in the prescribed time and those applications found otherwise defective will be deleted from the Probability List without further notice.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) SC/ST Candidates included in the Probability List are required to produce Community Certificate in Form III or Digitally Signed, Candidates belonging to other reservation groups are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009 issued by the Revenue authority at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **29-11-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER2-3/2/2026-KPSC DATED 28/01/2026.
