Note :- (5) Dependants of Ex-Service Personnel/Defence Service Personnel should produce a certificate in proof of heir claim from the Tahsildar concerned and in the absence of such certificate from the Tahsildar, a certificate obtained from the Commanding Officer concerned proving the relationship of the Applicant with the Defence Service Personnel with his name, Rank in Military and address in Military duly recorded there in, shall be produced.

Note :- (6) Candidates are required to produce a certificate(in original)of Physical Fitness from a

Medical Officer not below the Rank of Assistant Surgeon. The Certificate format can be downloaded from the Website of Kerala Public Service Commission.

Note :- (7) The Register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose Applications are found otherwise defective will be rejected without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on 27-10-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. **No candidates are invalidated as per Invalidation Notification No.ER16-2/10/2025-EW dated 31/12/2025.**
