Note :- (6) For Online Examination, rechecking and revaluation are not allowed but print out of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.

Note :- (7) The Register number of those candidates who do not produce the required documents within the prescribed time and those applications found otherwise defective will be rejected from the Probability List without further notice.
