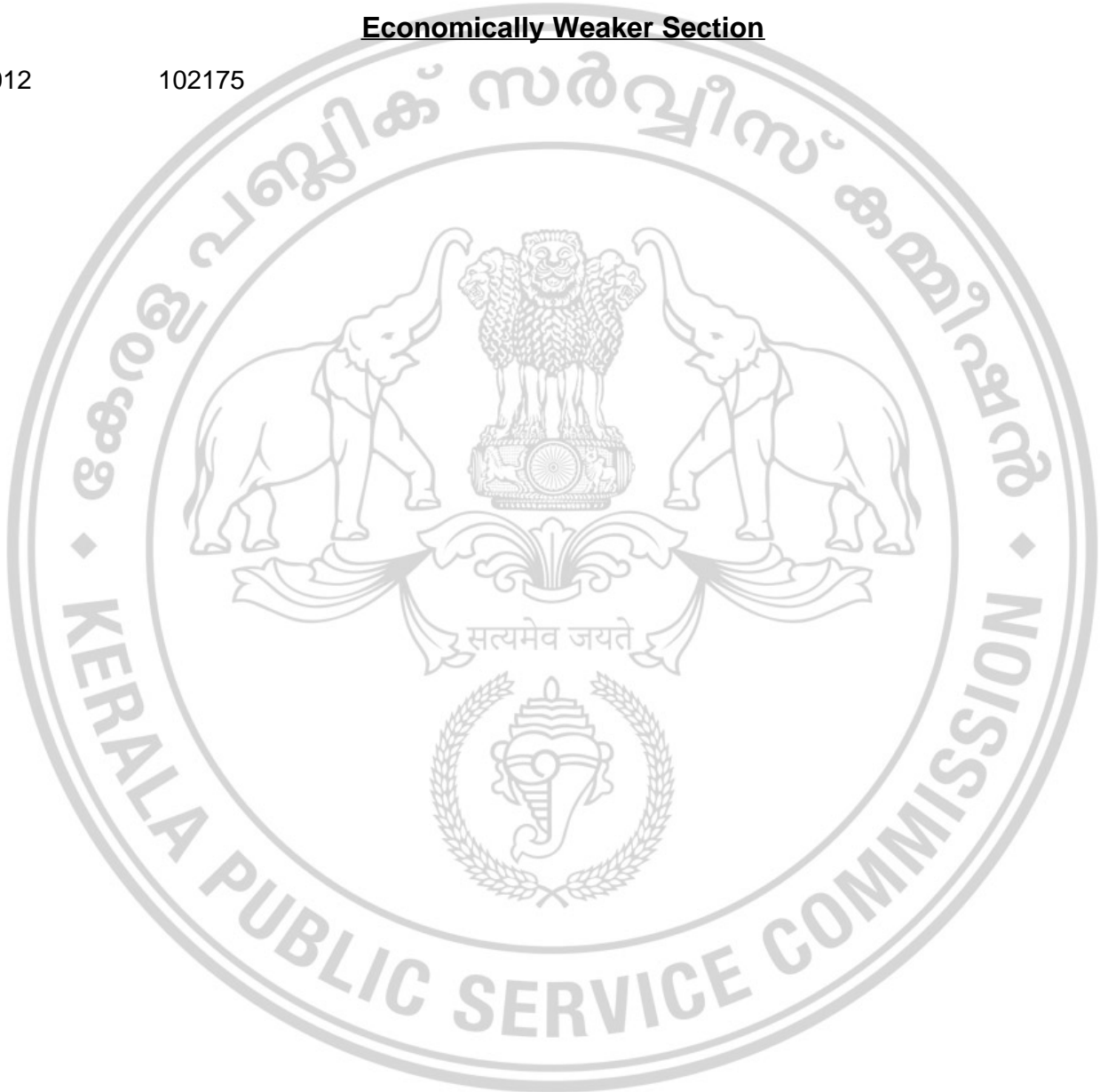

ote :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The Short list list has been prepared by including the number of eligible and qualified candidates who have secured top marks in the Online Test held on 17.02.2026 based on the details furnished by the candidates in the application. Subsequent claims made will not be entertained at any stage of selection.

Note :- (3) 10 candidates who have secured top most marks in the Online Test are included in the main list of short list. The marks secured by the last candidates in the main list of Short list is **52.67 ( fifty two (point) six seven )**. For the purpose of satisfying the rules of reservation of appointment to various available reservation groups, necessary supplementary list is prepared by including sufficient number of candidates from lower mark range in the order of meri of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification and interview will be intimated in due course through profile message and SMS.**

Note :- (5):-The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the shortlist without further notice.

Note :- (6) For online Examination rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to Other Backward Classes included in the Short List, eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O (P) No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O (Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate (Form III/ Digitally signed) issued by the Revenue Authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(Ms)No.02/2020/P& ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.
