Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The Short list has been prepared by including the number of candidates who have secured top marks in the Online Test. The list is prepared based on the details furnished by the candidates in the application and subsequent claim made will not be entertained at any stage.

Note :- (3) 11 (Eleven) candidates who have secured top most marks in the Online examination are included in the Main List of the Short List. The Marks secured by the last candidate in the main list is **59.33 (fifty nine point three three)** marks. For the purpose of satisfying the Rules of Reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, EWS, necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person and produce the original documents for One Time Verification and Interview. **Date, time and Venue of OTR Verification and Interview will be published in due course.** The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the short list without further notice.

Note :- (5) Candidates belonging to Other Backward Classes included in the Short List eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O(P) No 81/09/SCSTDD dtd 26/09/2009 or that obtained through e-district portal in the format prescribed in G.O (Rt) No 3942/2018/RD dtd 24/09/2018 and SC/ST candidates are required to produce Community Certificate (Form III/Digitally Signed) issued by the Revenue Authority not below the rank of Tahsildar and candidates who claim EWS Reservation are required to produce EWS certificate vide G.O (MS) No 2/2020/P&ARD dtd 12/02/2020 issued by the Village Officer in proof of their claim along with other documents at the time of OTR Verification of original documents.

Note :- (6) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the ranked list to be published for the post.
