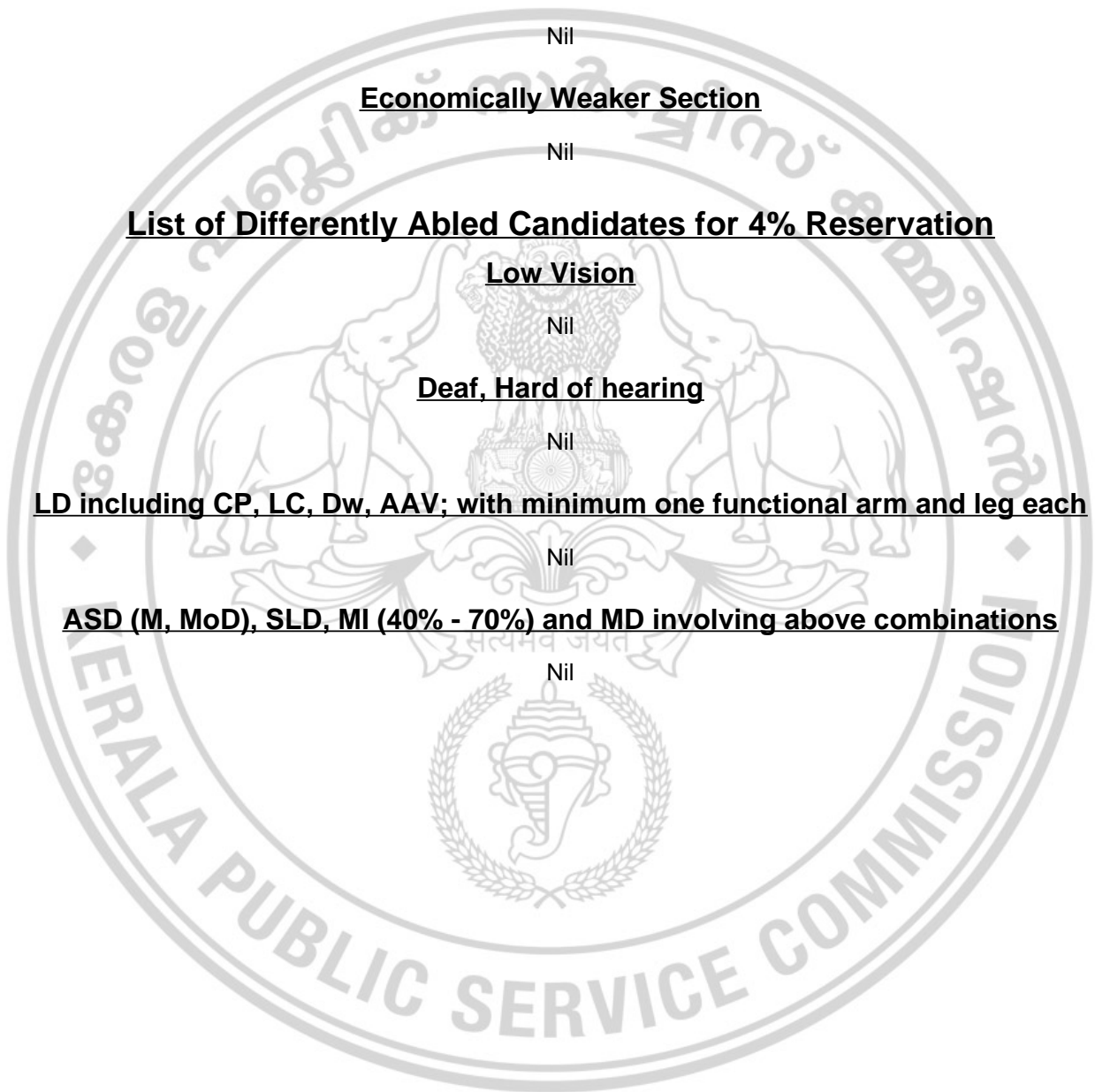

Note (4): Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date, time and venue of OT Verification and Interview will be intimated through Profile Message and SMS in due course.

Note (5): The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

Note (6): Candidates belonging to Other Backward Classes included in this Short List are required to produce a Non-Creamy Layer Certificate as per G.O. (P) No. 81/2009/SC/STDD dated 26.09.2009. Candidates belonging to SC/ST are required to produce a Community Certificate in Form III or a digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar. Candidates belonging to Economically Weaker Section are required to produce an EWS Certificate vide G.O. (MS) No. 2/2020/P&ARD dated 12.02.2020 issued by the concerned authority.

Note (7): According to the existing procedure, revaluation of answer scripts is not allowed, but answer scripts can be rechecked after the publication of the Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note (8): Copy of answer scripts of the common OMR Test held on 18.11.2025 will be issued to those candidates who apply for the same by remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No. ER7-1/11/2025-KPSC dated 01.01.2026
