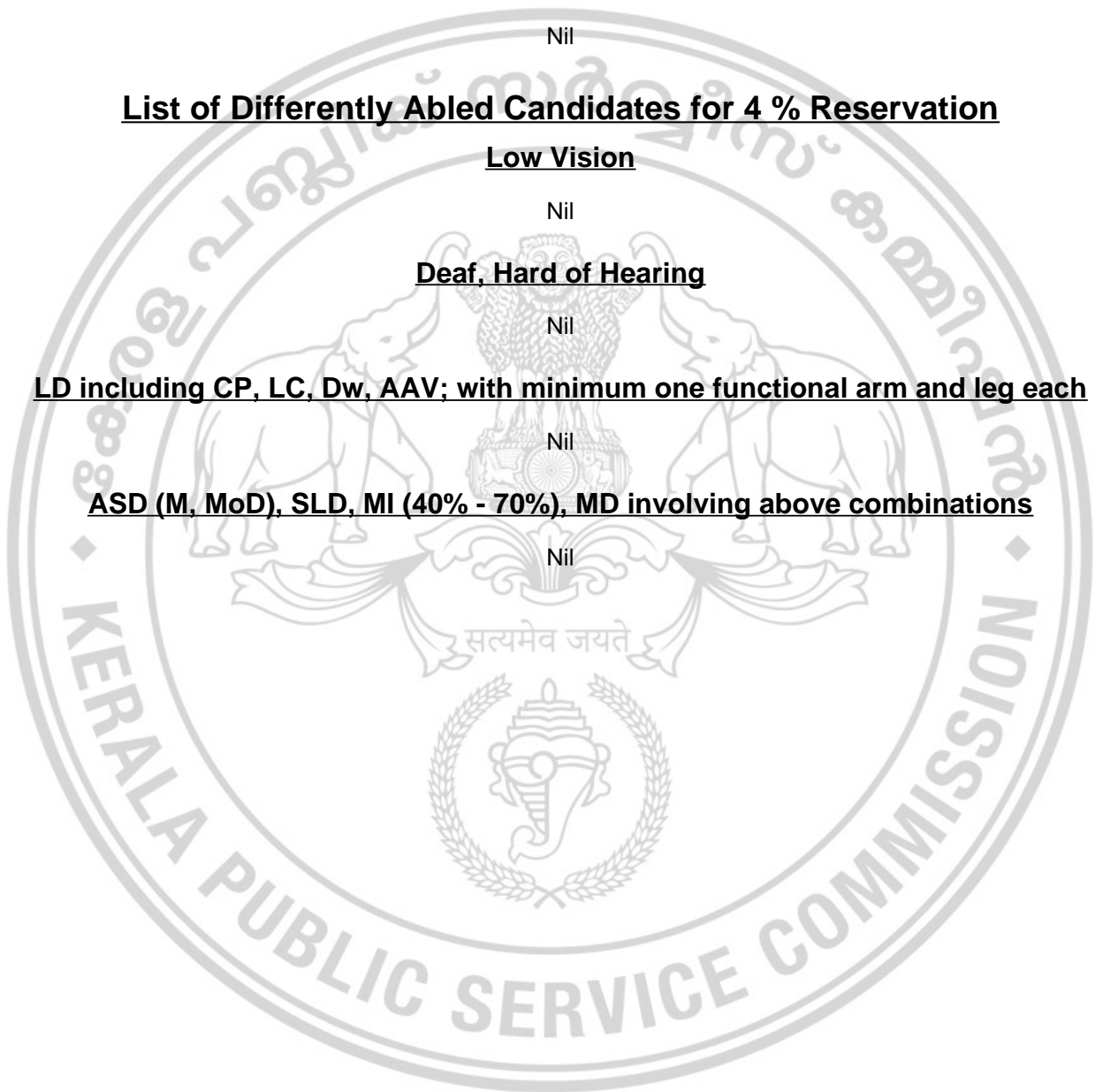

Note :- (5) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate issued by Village Officer as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar and EWS Certificate in case of candidates having EWS reservation along with other relevant documents at the time of OTR Verification and Interview.

Note :- (6) The Register numbers of those candidates who do not produce the required documents within the prescribed time and those applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) Copy of answer scripts of the OMR Test held on 18-11-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
