

Note :- (3) **30 (Thirty)** candidates who have secured top most marks in the OMR examination are included in the Main List of this Probability list. The Marks secured by the last candidate in the Main List is **58.33 (fifty eight (point) three three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including available/sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should be present and produce in person the original documents for One Time Verification. **Date, time and Venue of OT Verification will be published in due course.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated:26.09.2009 issued by concerned Village Officer, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahsildar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the concerned authority at the time of OT verification.

Note :- (7) Copy of answer scripts of the Common OMR Test held on 27-10-2025 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No:ER16-2/10/2025-KPSC DATED:03.01.2026.
