The Shortlisted Candidates should download their Admission tickets for the Physical Measurement and Physical Efficiency Test from their OTR Profile, logging on to the official website www.keralapsc.gov.in of Kerala Public Service Commission and appear in person with their Admission Ticket, Original ID proof and Medical Certificate (in the form prescribed as per the Gazette notification) issued by a Medical Officer not below the rank of Assistant Surgeon/Junior Consultant at the time of Physical Measurement and Physical Efficiency Test.

Note:- (5) Candidates included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018, at the time of OTR verification of original documents.

Note:- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note:- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Copy of answer scripts of the OMR Test held on 24-01-2026 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.

Note:- (8) No answer scripts are invalidated as per Notification No : ER1-1/3/2026-KPSC Dated 06.05.2026 of the Secretary, KPSC, Thiruvananthapuram.
