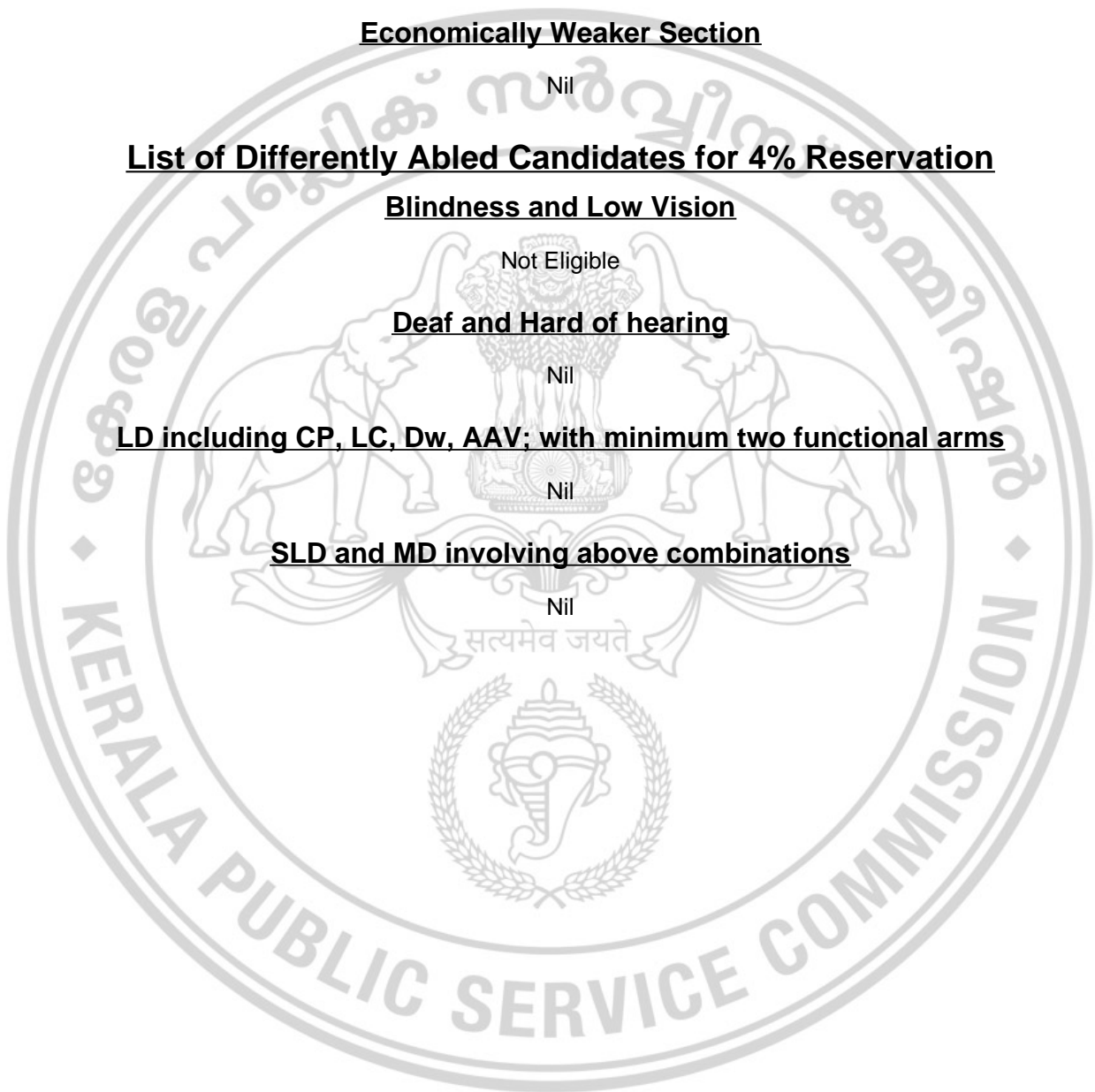

Note :- (5) The Register Number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O (P) No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O (Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate (Form III/ Digitally signed) issued by the Revenue authority not below the rank of Tahsildar along with other documents at the time of OTR verification of original documents

Note :- (7) For Online Examinations, rechecking and revaluations are not permitted. However, a printout of the answer sheet will be issued to candidates who apply within the prescribed time limit, following the publication of the Ranked List and payment of the requisite fee. Detailed instructions will be included in the Ranked List to be published for the post.
