Note:- (2) The Short List has been prepared based on the details furnished by the candidates in the Application and subsequent claims, if any, made will not be entertained at any stages of selection.

Note:- (3) **76 (Seventy Six)** candidates who have secured topmost marks in the Common OMR Examination held on 25.02.2026 are included in the Main List of this Short list. The lowest mark of the candidates in the Main List is **31.6700 (Thirty One (point) six seven zero zero)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Short List should be present in person and produce the original documents for **Physical Measurement and Practical Test (T - test and Road test)**. **Date, Time and Venue of Physical Measurement and Practical Test (T - test and Road test) will be intimated through profile message and SMS in due course.**

Note:- (5) **Candidates must possess a valid Driving License with endorsement for driving Heavy Goods vehicle and Heavy Passenger Vehicle with badge throughout all stages of selection, i.e., on the last date for receipt of Application, Date of OMR Test, Date of Practical Test and on the date of OTR verification of original documents.**

Note:- (6) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar and candidates belonging to EWS category are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the Village Officer as proof of their calim, along with relevant documents at the time of OTR verification of original documents.

Note:- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post

Note:- (8) Copy of answer scripts of the OMR Test held on 25-02-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
