Copy of answer scripts of the Common OMR Test held on 20.12.2025 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List

Note (5) :- Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per G.O. (P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 issued by the Revenue authority at the time of OTR Verification.
