Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note:- (2) **119** candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Short list and the lowest mark secured by the candidates to be included in the Main List is **80.3300 ( eighty (point) three three zero zero )** For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates.

Note:- (3) The Short List is prepared based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage.

Note:- (4) Candidates included in the Short List should be present in person for Physical Measurement and Physical Efficiency Test with the original ID proof and admission ticket issued for the said test. Date, Time and venue for the same will be intimated in due course through SMS and Profile message. The shortlisted candidates should download their Admission Ticket for Physical Measurement and Physical Efficiency Test from their OTR profile, logging on to the official website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) of Kerala Public Service Commission and appear in person with their Admission ticket, original ID Proof and Medical certificate (in the form prescribed as per the Gazette notification) issued by a Medical Officer not below the rank of Assistant Surgeon/Junior Consultant at the time of Physical Measurement and Physical Efficiency Test.

Note:- (5) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018. SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar, along with other documents, at the time of OTR verification of original documents. Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note:- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note:- (7) According to the existing procedure, revaluation of answer script is not allowed but, answer scripts can be rechecked after the publication of the Ranked List. Copy of answer scripts of the OMR Test held on 24-01-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note:- (8) Candidates whose Register Numbers are not included in the short list are advised to refer to Notification No.ER 1-1/3/2026-KPSC dated 06.05.2026 of the Secretary, Kerala Public Service Commission, Thiruvananthapuram, also to see whether their answer scripts have been invalidated.
