Note :- (2) The list has been prepared based on the details furnished by the Candidates in the Application and Subsequent claim, if any, made will not be entertained at any stage.

Note :- (3) 59 candidates who have secured topmost marks in the OMR Examination are included in the Main List of the Short List. The marks secured by the last candidate in the Main List is **73.33 (seventy three (point) three three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section and Differently Abled, necessary Supplementary Lists are prepared by including sufficient number of candidates from lower mark ranges, belonging to such classes.

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post. Copy of answer scripts of the OMR Test held on 28-02-2026 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (5) Candidates included in the Short List should present in person and produce the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (6) Candidates included in the Short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O(Rt) No 3942/2018/RD dated 24.09.2018. SC/ST candidates are required to produce Community Certificate issued by the Revenue Authority in the format prescribed in Kerala (Scheduled Castes and Scheduled Tribes) Regulation of issue of Community Certificates Rules,2002. The Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(Ms)No.05/2020/P& EA dated 04.03.2020 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (7) Candidates whose Register Numbers are invalidated are advised to refer to Notification No: ER1-1/4/2026-KPSC Dated:06.05.2026 of the Secretary, KPSC, Thiruvananthapuram.
