Note:- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The list has been prepared by including the number of Eligible and Qualified candidates who have secured top marks in the OMR Test.

Note :- (3) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (4) **74** candidates who have secured **30.67 (Thiry(point) Six Seven)** marks and above in the common OMR test held on 25.02.2026 are included in the mainlist of the Short List. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (5) Candidates included in the Short List should be present in person and produce the original documents(Admission Ticket, ID proof, Latest Extract of Driving License, Valid Driving License, Medical Certificates regarding Physical Fitness and Vision) for Physical Measurement and Practical Test. The shortlisted candidates should download their admission tickets for the Physical Measurement and Practical Test from their OTR profiles. Date, time and Venue of Physical Measurement and Practical Test will be informed through Profile Message / SMS in due course.

Note :- (6) **Candidates must possess a valid Driving License with endorsement for driving Heavy Goods Vehicle or Heavy Passenger Vehicle with Badge throughout all stages of selection, i.e., on the last date of application, Date of OMR Test, Date of Physical Measurement and Practical Test, Date of OTR Verification etc.**

Note:- (7) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents. Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.03/2024/P&ARD dated 25.04.2024 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note:- (8) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note:- (9) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (10) Copy of answer scripts of the OMR Test held on 25-02-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No.: ER16-3/4/2026-KPSC Dated 08.05.2026.
