The candidates should download their Admission Tickets for Physical Measurement and Physical Efficiency Test from the official website www.keralapsc.gov.in of Kerala Public Service Commission and appear in person with Admission Ticket, original ID Proof and Medical Certificate. The Medical Certificate should be in the format prescribed in the Gazette notification certified by a Medical Officer not below the rank of an Assistant Surgeon/Junior Consultant.

Note:-(4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post. Copy of answer scripts of the OMR Test held on 20/12/2025 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (5) Candidates included in the Short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate (for State Employment purpose) obtained from Village Officer as per GO(P) No.81/09/SCSTDD dated 26.09.2009. SC/ST candidates are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority (not below the rank of Thahildar). Candidates who claim EWS reservation are required to produce EWS Certificate issued by the Revenue authority along with other documents at the time of OTR verification of original documents.
