Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification will be intimated through profile Message and SMS in due course.

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/09/SC/STDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O(Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per G.O.(MS) No.2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note :- (7) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on 05-11-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Answer Scripts of Candidates are invalidated as per Notification No :ER15-2/2/2025-KPSC Dated 25.2.2026.
