Note:- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The list has been prepared by including the register number of candidates who have secured top marks in the OMR test.

Note:- (3) **76** candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Short list. Out of the 76 candidates in the Main List, the lowest mark secured to be included in the Main List is **41.00 (forty one (point) zero zero)** For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates.

Note:- (4) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note:- (5) Candidates included in the Short List should be present in person and produce the original documents (Admission Ticket, ID proof, Latest Driving Licence Extract, Driving Licence Medical Certificate regarding Physical Fitness and Eyesight) for Physical Measurement and Practical Test. OTR verification will be conducted after qualifying Physical Measurement and Practical Test (T Test and Road Test). **Date, Time, and Venue of Physical Measurement and OTR Verification will be intimated through profile message and SMS.** The shortlisted candidates should download their Admission Tickets for the Physical Measurement and Practical Test from their OTR profiles.

Note:- (6) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents. Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 /GO(Ms) No.5/2020/P&EA dated 04.03.2020 (for public sector undertaking) issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note:- (7) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (8) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (9) Candidates must possess a valid Driving Licence with endorsement for driving Heavy Goods Vehicle and Heavy Passenger Vehicle throughout all stages of selection. ie on the last date of Application, Date of OMR Test and Practical Test.

Note:- (10) Copy of answer scripts of the OMR Test held on 25-02-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers invalidated are advised to refer to Notification **No ER16-3/4/2026-KPSC dated 08.05.2026.**
