For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Sections, necessary supplementary lists have been prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and interview. **Date,time and Venue of One Time Verification and interview will be informed through profile message and SMS in due course.**

Note :- (6) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009. SC/ST candidates are required to produce Community Certificate issued under Rule 4 of the Kerala (SC/ST) Regulations of Issue of Community Certificate Rules, 2002 by the Revenue Authority not below the rank of Tahsildar. Candidates claiming reservation under the EWS category are required to produce EWS Certificate issued by the Village Officer as per G.O.(Ms) No.2/2020/P&ARD dated 12.02.2020 as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note :- (7) For Online Examination ,rechecking and revaluation are not allowed but print out of the answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of the Ranked List. Detailed instructions will be furnished in the Ranked list to be published for the post.
