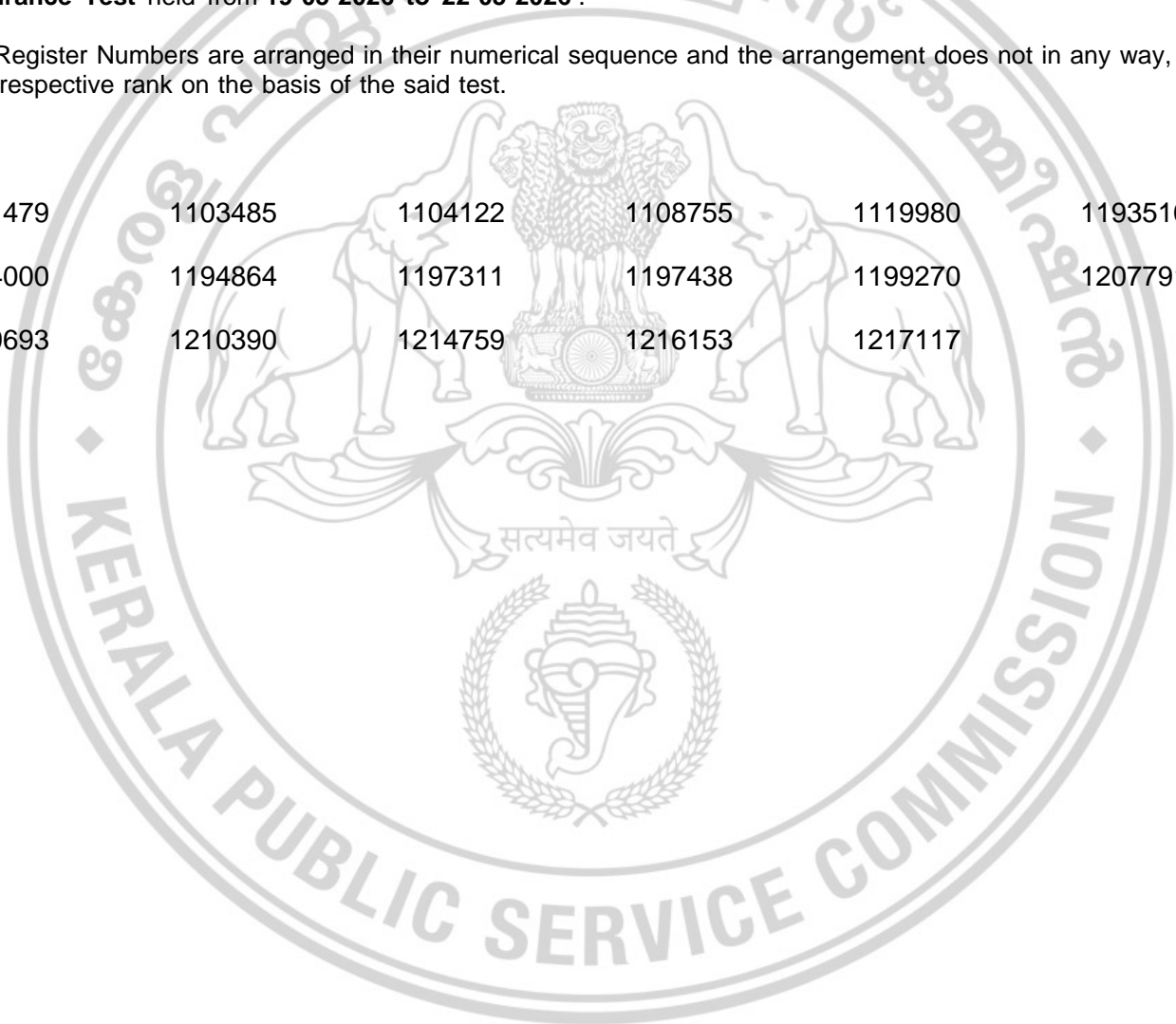

Note :- (3) Candidates included in the Short List should present in person for Physical Measurement and Physical Efficiency test with the Original ID proof and admission ticket issued for the said test. Date ,Time, and Venue of the said Test will be intimated in due course through SMS and profile Message. The shortlisted candidates should download their Admission Tickets for the above test from their OTR profiles ,logging on to the official website "www.keralapsc.gov.in" of Kerala Public Service Commission and appear for the test with necessary documents. The shortlisted candidates are directed to produce a Medical certificate (in the form prescribed as per the notification) issued by a Medical Officer not below the rank of Assistant Surgeon/Junior Consultant at the time of Physical Measurement and Physical Efficiency Test.

Note :- (4) The Physical Measurements of candidates will be taken prior to the Physical Efficiency Test and those who do not possess the prescribed physical measurement will not be admitted for the Physical Efficiency test. If accidents or injuries happen to a candidate while participating in the Physical Efficiency Test, he will not be given further chance to participate in the test.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority not below the rank of Tahsildar and Medical certificate in the prescribed form as per Gazette Notification obtained from a Medical officer not below the rank of an Assistant Surgeon along with other documents at the time of OTR verification
