Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date, time and Venue of OTR Verification and Interview will be intimated through profile message and SMS in due course.

Note :- (5) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate issued by Village Officer as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar and EWS Certificate vide G.O (Ms) No.5/2020/P&EA dated 04/03/2020 issued by Revenue Authority, in case of candidates having EWS reservation along with other relevant documents at the time of OTR Verification and Interview.

Note :- (6) The Register numbers of those candidates who do not produce the required documents within the prescribed time and those applications found otherwise defective will be deleted from the Short List without further notice

Note :- (7) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post..
