NOTE (1):- The result of the candidate with **Interview Sl.No.3** is withheld subject to further orders in **OA No. 516/2026**.

NOTE(2):- Since a Common Online Test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of Online Test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists which will be finalized on the basis of the Common Test. Please note that in the case of Ranked lists of those posts for which common examinations were conducted, the copy of Online answer sheets will be provided only after the publication of all the Ranked lists of those posts for which the candidate has participated.

NOTE(3):- The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. **Rules of Reservation and Rotation(Rules 14 to 17 of KS & SSR 1958)** shall not be applicable in the case of appointment by transfer and candidates whose names are arranged in the order of merit in the ranked list shall be advised. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the Ranked List.

NOTE(4):- Advice of candidates will be made from the ranked list that shall be prepared for By Transfer Recruitment. A ranked list for Direct Recruitment will be prepared and candidates will be advised from that list only if vacancies remain after advising all the candidates included in the Ranked List for By Transfer Recruitment.

NOTE(5):- For Online examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those who apply for it by remitting the prescribed fee. Candidates who wish to obtain a printout of their answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in, by remitting the prescribed fee of **Rs.335/- (Rupees Three Hundred And Thirty Five Only)** via e-payment mode available in the portal. A period of **15 (Fifteen) days** time to apply for printout of answer sheets will be allowed to candidates with effect from the date on which the Ranked list is uploaded in the website of the Commission.(ie. On or before **06.08.2026**). Application submitted in any other manner (ie. Via email/tappal/direct) will not be considered. A copy of an answer sheet will be issued only once to a candidate.

NOTE(6):- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to **The Secretary, KPSC, Pattom, Thiruvananthapuram-695004**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment, along with the original of notarized affidavit and self attested copy of the ID proof, received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on

or before the date of receipt of vacancy, based on which he/she is to be advised.
