Note : (2) For Descriptive Examination rechecking and revaluation are not allowed. If the Candidate wish to obtain scanned image and Tabulation Sheet of Answer sheet of Descriptive Examianation,online application through the One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in shall be submitted by remitting the prescribed fee of Rs.335/- (Rupees three hundred and thirty five) via e- payment mode available in the portal. A period of 15 (Fifteen) days time to apply for the scanned image and Tabulation sheet of answer sheet will be allowed to the candidate with effect from the date on which the Ranked List is uploaded in the website of the Commission (ie on or before **06/08/2026**). Application submitted in any other manner(i.e. via email/Tappal/Direct) will not be considered. Scanned image and Tabulation sheet of Answer sheet of the Descriptive Examination will be issued only once to a candidate.

Note: (3) The entries put in column (8) are based on the Community specified by the candidate in the Application form and proved with necessary documents.If the Community has not been correctly noted in the Ranked List as proved in the Application of the candidate should intimate the fact to the **The District Officer, Kerala Public Service Commission,District Office, Idukki,685508** within one month from the Date of publication of the Ranked List to get the benefit of Reservation which the candidate is entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

Note: (4) Candidate who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to **THE DISTRICT OFFICER, KERALA PUBLIC SERVICE COMMISSION, District Office, Idukki,685508**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with Signature,Name,Designation and Office seal along with a Notarized Affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment along with a Notarized Affidavit and a self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. In the case of the requisition of vacancies received after the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.
