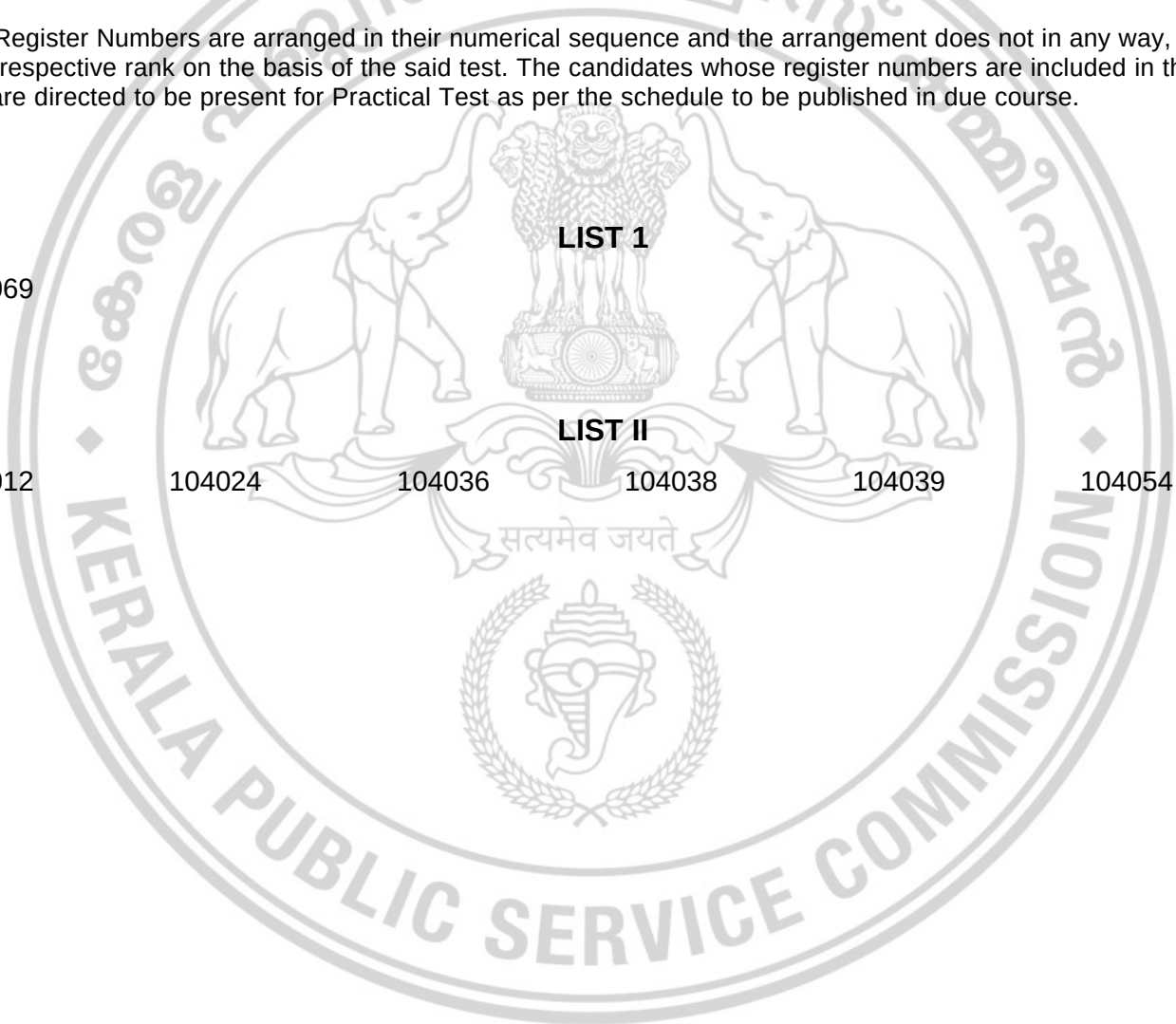

Note:- (5) Candidates called for the practical test will have to produce Medical certificate in the prescribed form from a Medical Officer not below the rank of an Assistant Surgeon. A Medical Certificate regarding eye sight from an Ophthalmologist in Government Service also will have to be produced along with other necessary documents such as valid Driving Licence etc. Form of Medical certificates is available in the Notification.

Note:- (6) For Online Examination, rechecking and revaluation are not allowed, but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
