Subsequent claims made will not be entertained at any stage of selection.

Note:- (3) **No candidate** with the qualification specified in **Para 7 (i) , (ii - 1) & iii** of the Gazette Notification for the post are eligible and qualified to be included in the **List I** of the Short List. Candidates with the qualification as specified in the **Para 7 (i) , (ii - 2) , iii** and **Exemption Para 2 & 3** of the Gazette Notification have been included in the **List II** of the Short List

Note:- (4) **09** candidates who have secured topmost marks in the Online Examination are included in the **List II - Main List** of this Short list. Out of the **09** candidates in the Main List, the lowest mark secured to be included in the Main List is **42.00 (Fourty Two (point) Zero Zero)** For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates.

Note:- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification and interview** will be intimated to candidates through **Profile message and SMS** in due course.

Note:- (6) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents. Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note:- (7) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note:- (8) For Online Examination, rechecking and revaluation are not allowed, but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
