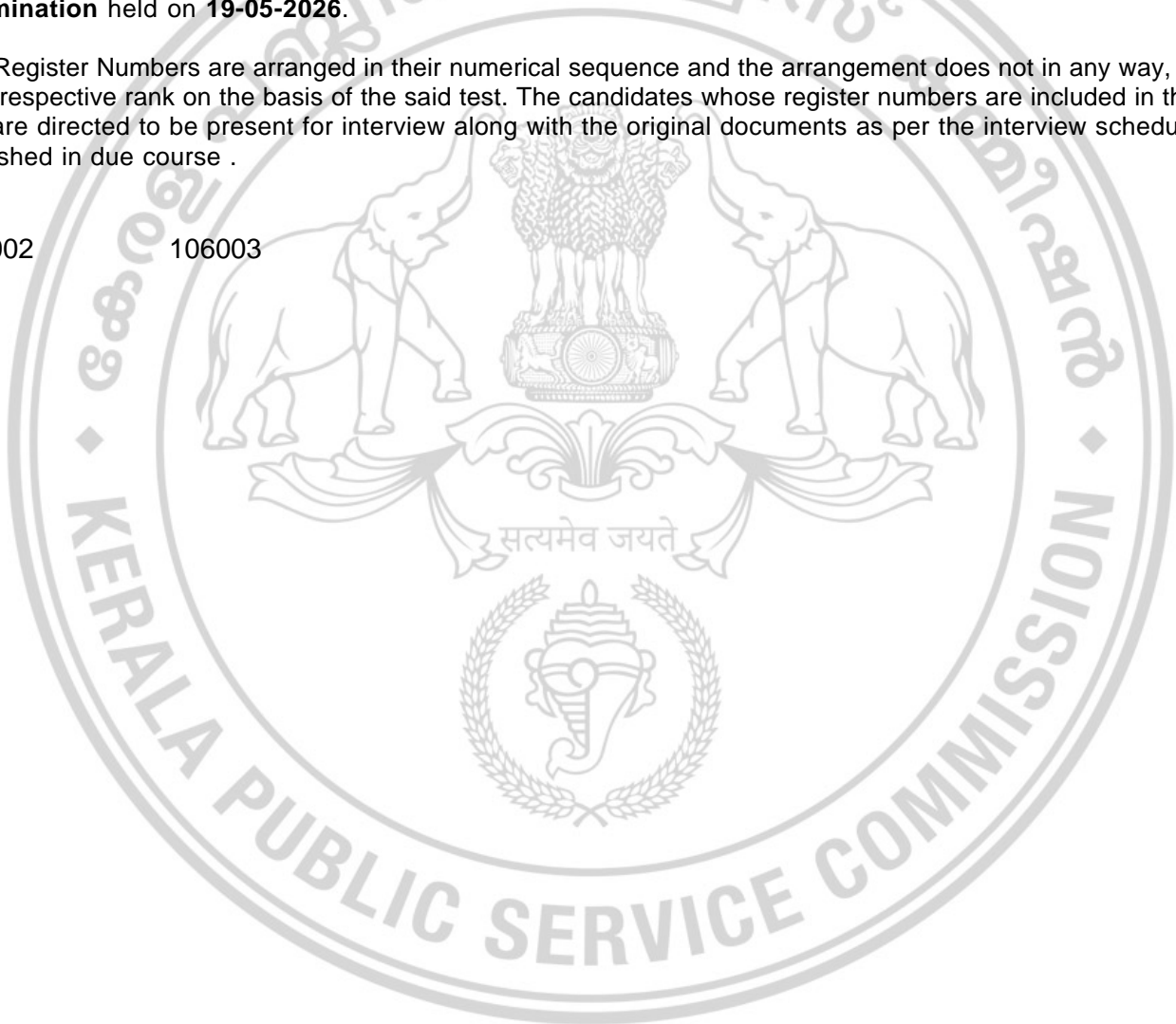

Note :- (7) For Online examination, rechecking and revaluation are not allowed but print out of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of the Ranked List.
