**Note :- (3)** No candidates with qualification specified in Para 7 ii(1) & (3) of the Gazette Notification for the post are eligible and qualified to be included in List I & List III of the Short List. 4 candidates with the qualification as specified in the Para 7 (i) ,ii(2) & iii have been included in the List II of the Short List. 4 candidates with the qualification as specified in the Para 7-Note(4) of the Gazette Notification for this post have been included in the List IV of the Short List. The candidate appointed under this provision will have to acquire B.Ed Degree at their own expense within five years from the date of entry in service.

**Note :- (4)** Eligible and qualified candidates who have obtained 11.6700 Mark and above are included in List II and candidates who have obtained 11.3300 Mark and above are included in List IV of the short List.

**Note :- (5)** Candidates included in the Short List should be present in person and produce the original documents for One Time Verification. The Date, Time and Venue of OTR Verification and Interview of the candidate included in this Short List will be intimated in due course through SMS/Profile message.

**Note :- (6)** Candidates included in the Short List are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification.

**Note :- (7)** The Register Numbers of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Shortlist without further notice.

**Note :- (8)** For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after

the publication of the Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
