The shortlisted candidates should download their admission tickets for the Endurance Test from their OTR profiles logging on to the official website - www.keralapsc.gov.in of the Kerala Public Service Commission and appear for the test with necessary documents.**

Note:- (5) Candidates included in the Short List are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (7) Copy of answer scripts of the OMR Test held on 06-05-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers invalidated are advised to refer Notification No.ER16-3/5/2026-KPSC dated 24-06-2026 of the Secretary, Kerala Public Service Commission.
