The shortlisted candidates should download their admission tickets for the Endurance Test from their OTR profiles logging on to the official website - www.keralapsc.gov.in of the Kerala Public Service Commission and appear for the test with necessary documents.**

Note:- (5) Candidates included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 along with other documents at the time of OTR verification of original documents.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (7) Copy of answer scripts of the OMR Test held on 06-05-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers invalidated are advised to refer Notification No.ER16-3/5/2026- KPSC dated 24.06.2026.
