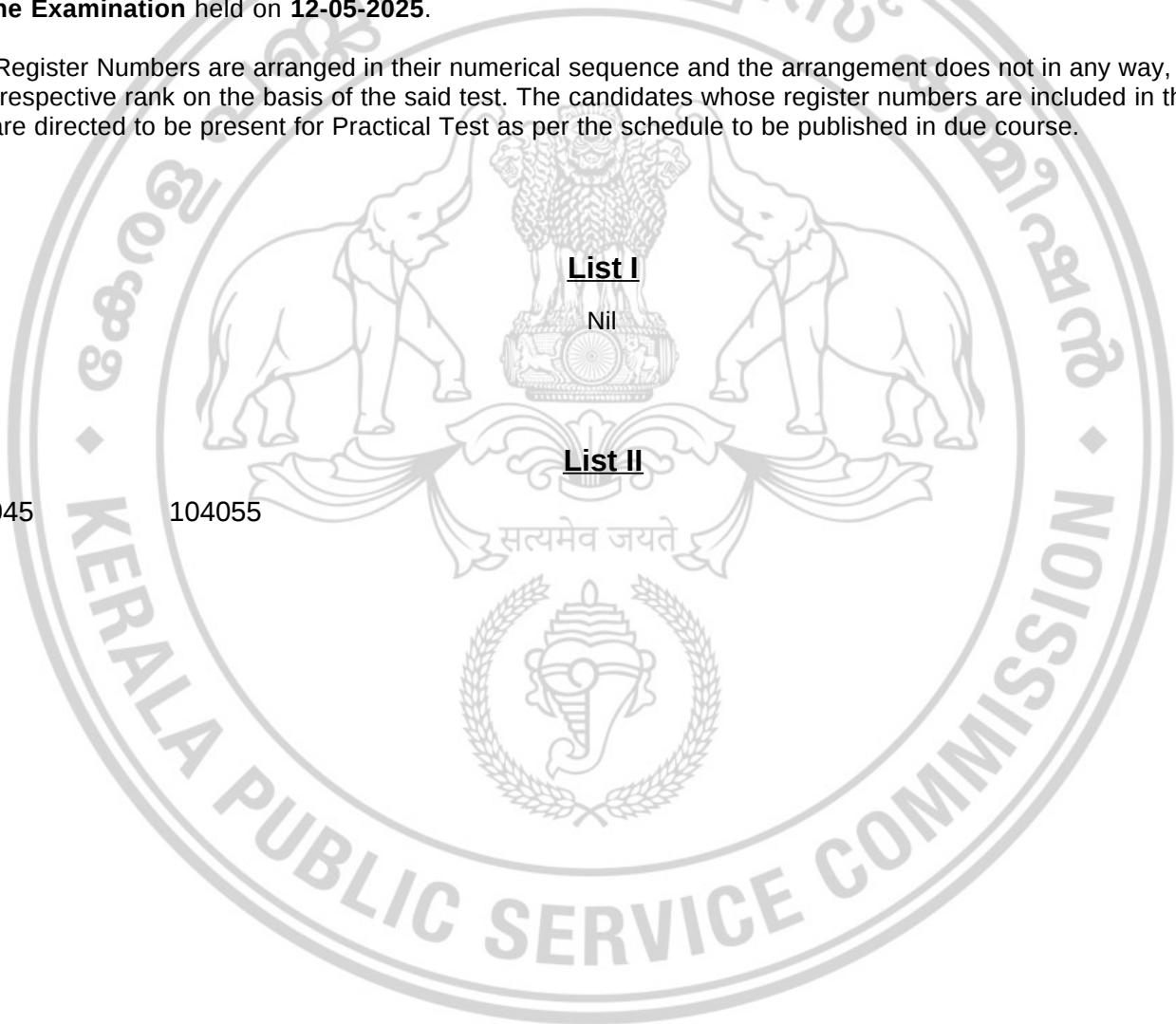

Note:- (4) Candidates included in the Short List should be present in person and produce the original documents, for **Practical Test** and **One Time Registration Verification** after qualifying Practical Test. **Date, Time and Venue of Practical Test and OTR Verification will be intimated through profile message and SMS.**

Note:- (5) candidates called for the practical test will have to produce Medical certificate in the prescribed form from a Medical Officer not below the rank of Assistant Surgeon. A Medical certificate regarding eye sight from an Ophthalmologist in Government Service also will have to be produced along with other necessary documents such as valid Driving License etc. Candidates should possess current valid Driving Licence through out all the stages of selection process i.e, on the last date of receipt of application, OMR Test, Practical Test and OTV. **Form of Medical certificates is available in the Notification.**

Note:- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note:- (7) For Online Examination, rechecking and revaluation are not allowed, but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
