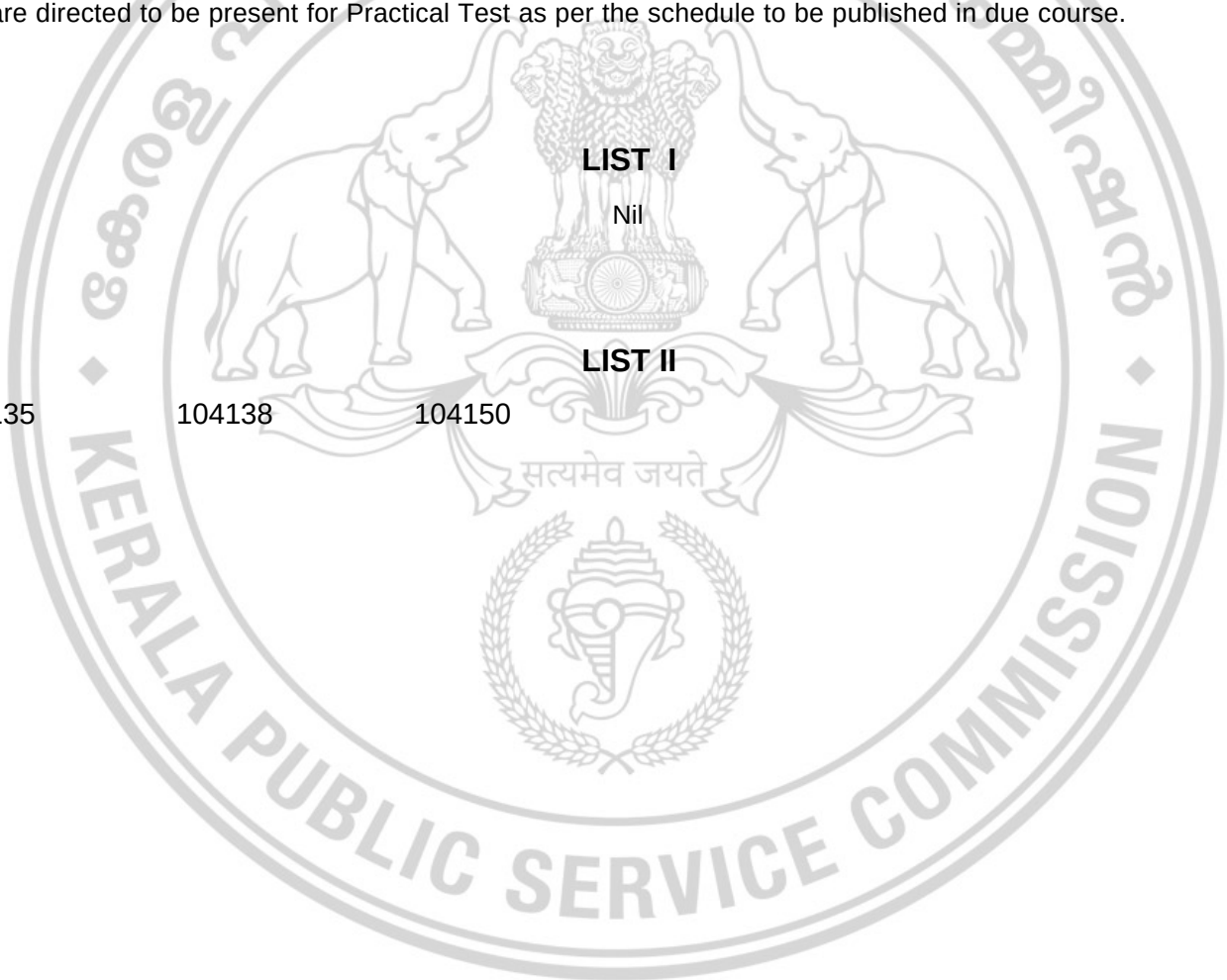

Note:- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note:- (2) There are no candidates in List I , since no candidate is available with the prescribed qualification to be included in List I as per the Notification. The LIST II has been prepared by including all eligible and qualified candidates who have qualifications as prescribed in the notification to be included in List II.

Note:- (3) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note:- (4) Candidates included in the Short List should be present in person and produce the original documents, for Practical Test and One Time Registration Verification after qualifying **Practical Test. Date, Time and Venue of Practical Test and OTR Verification will be intimated through profile message and SMS.**

Note:- (5) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents. Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 /GO(Ms) No.5/2020/P&EA dated 04.03.2020 (for public sector undertaking) issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note:- (6) Candidates called for the practical test will have to produce Medical certificate in the prescribed form from a Medical Officer not below the rank of Assistant Surgeon. A Medical certificate regarding eye sight from an Ophthalmologist in Government Service also will have to be produced along with other necessary documents such as valid Tractor Driving License etc. **Candidates should possess current valid Tractor Driving Licence through out all the stages of selection process i.e, on the last date of receipt of application, OMR Test, Practical Test and OTV.** Form of Medical certificates is available in the Notification.

Note:- (7) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note:- (8) For Online Examination, rechecking and revaluation are not allowed, but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
