The following is the list of candidates for selection to the post of **FOREST DRIVER (1st NCA OBC) (Cat No.566/2024)** on **Rs.26500-60700/-** in **FOREST AND WILD LIFE DEPARTMENT IN WAYANAD DISTRICT**, found suitable by the Commission and arranged in the order of merit based on the Common OMR Test held on 26/08/2025, Physical Measurement & Physical Efficiency Test held on 16.02.2026, 17.02.2026, 18.02.2026 and the Practical Test (T TEST AND ROAD TEST) held on 14.05.2026 and 15.05.2026 for the recruitment against the NCA vacancies for **OBC** Community . This Ranked List is brought into force with effect from **30.07.2026** and will be valid until the candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to **OBC** Community during the currency of the Mother Ranked List published on 08.06.2021 (Category No. 120/2017) for the post.

NOTE (1) :- The result of the candidates with Register Numbers 1230965, 1234910 and 1233700 are withheld.

NOTE (2) :- According to the existing procedure, revaluation of Answer script is not allowed. But Answer scripts will be rechecked if the candidates apply only through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eight Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner i.e. e-mail/ Tappal / By Hand will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (i.e, on or before 25.08.2026).

NOTE (3) :- Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335/- (Rupees three hundred and thirty five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (i.e, on or before 25.08.2026). Application submitted in any other manner i.e. e-mail/ Tappal / By Hand will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. "Please note that in the case of Ranked Lists of those posts for which common examinations were conducted, the printout of Answer sheets will be provided only after the publication of all Ranked Lists of those posts for which the candidate has participated".

NOTE (4) :- The entry put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their application should intimate the fact to the **District Officer, Kerala Public Service Commission District Office, MGT Building, Kalpetta North, Wayanad - 673122** within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (5) :- The Candidates who wish to relinquish their claim for advice from their Ranked List shall submit an application in the format prescribed by the Commission addressed to the **District Officer, KPSC District Office, Wayanad, Kalpetta North, Wayanad - 673122** either directly or by post. The format is available in the official website of the Commission. Those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Condition. The request for relinquishment received with 15 days from the date of uploading of Ranked List in the official website of the Commission will be honored against the requisitions of vacancies that are pending with the Commission upto the finalization of the Ranked List. After the publication of Ranked List the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (6) :- Since a common OMR test with common Candidates was conducted for the post, the marks awarded to the Candidate included in the Ranked List will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalized on the basis of

the common test. The result of rechecking of OMR answer script will be intimated in due course.

NOTE (7) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the last Ranked list, included in the common test.
