Note:- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of Application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note:- (2) **200(Two Hundred)** candidates who have secured top most marks in the OMR Examination held on 23.05.2026 are included in the Main List of this short List. Out of the 200 candidates in the Main List, the lowest mark secured by the candidate is **49.6489 (forty-nine (point) six four eight nine)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates.

Note:- (3) The Short List is prepared based on the details furnished by the candidate in the Application and subsequent claims made will not be entertained at any stage.

Note:- (4) Candidates included in the Short List should be present in person for Endurance Test with the original ID Proof, Admission Ticket issued for the said Test and other necessary documents. Date, Time and Venue of Endurance Test will be intimated through SMS and profile message. The shortlisted candidates should download their Admission tickets for the Endurance Test from their OTR profiles logging in to the official website - www.keralapsc.gov.in of the Kerala Public Service Commission and appear for the test with necessary documents.

Note:- (5) Candidates belonging to the Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahildar and Candidates belonging to Economically Weaker Section are required to produce EWS Certificate in the format prescribed vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the Village Officer as proof of their claim, along with other relevant documents at the time of OTR verification of original documents.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.

Note:- (7) Copy of answer scripts of the OMR Test held on 23-05-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER7-1/5/2026-KPSC Dated 06-08-2026.
